


## Cash Lifestyle funds' performance for 1 April to 30 June 2021

The Cash Lifestyle option is designed for those who may want to access their savings in a single cash lump sum. Up to 25% of this would be tax free, and the rest will be taxed as income. If you have not made any investment choices, you will be invested in this option. Below we show the past performance for this option over the three months to 30 June 2021.
