


New Drawdown Lifestyle funds' performance for 1 April to 30 June 2021

The Drawdown Lifestyle option is designed for those who may want to access their savings through Income Drawdown. This option lets you access money flexibly either as a one-off lump sum, or series of lump sums, while the rest of your money stays invested in your pension pot. Below we show the past performance for this option over the three months to 30 June 2021.

What does this mean for me?

This chart shows which fund you are invested in during your time in the Drawdown Lifestyle option.

The investment funds change near to retirement to decrease the level of risk you face over time.

Prepare – At retirement

Your savings are 70% invested in the Diversified fund and 30% invested in Cash.

Prepare – from 10 years to retirement

Your savings begin switching into the Cash Fund

Consolidate – from 20 years to retirement

Your savings begin switching into the Schroders Diversified Growth Fund

Grow – more than 20 years from retirement

Your savings are 100% invested in the BlackRock Aquila (30:70) Currency Hedged Global Equity Fund
